## INSTRUCTIONS: How to Use the Property Shipping Request and Acknowledgement of Receipt

The Property Shipping Request and Acknowledgement of Receipt forms are available in case you are unable to retrieve your lost/found property in person and wish to have it shipped to your address in Japan .

To make a request with the forms, please contact the appropriate police office (i.e., custodian of your lost/found property) in advance.
